Rule 801(d)(1)(B) states that a statement is not hearsay if "[t]he declarant testifies at the trial or hearing and is subject to cross-examination concerning the statement, and the statement is... inconsistent with his testimony and was given under oath subject to the penalty of perjury at a trial, hearing, or other proceeding, or in a deposition." Because of the procedural posture of the case, there has been no pretrial ruling on the admissibility of any particular prior consistent statement as required by Rule 801(d)(1)(B). See 3 J.
